Cookie Policy (PECR, UK GDPR and DPA 2018)

Personal data is any information that directly or indirectly identifies you which includes, without limitation, your personal details, transactions and use of our products and services as part of your relationship with us.

- **1.1.** Our website and the functionality of our online information, trading and reporting platform are available through our website (and any related sub-domains), which if you are our client enables you to access and manage the investments for and on behalf of the investors (Timeline) use cookies to distinguish you from other users. This helps us to provide you with a good experience when you browse our website or access the Timeline and also allows us to improve those. You can find out more about cookies and how to control them in the information below.
- **1.2.** A cookie is a small piece of data (file of letters and numbers) that a website asks a visiting user to store on their device in order to remember information about them. Cookies contain information that is transferred to your computer's hard drive. Those cookies are set by us and called first-party cookies. We also use one type of third-party cookies which are cookies from a domain different than the domain of the website you are visiting for our analytical and performance efforts.
- **1.3.** We use the following types of cookies:
 - **1.3.1.** Strictly necessary cookies. These are cookies that are required for the Timeline App to function and cannot be switched off in our systems. They are usually only set in response to actions made by you that amount to a request for services, such as logging into secure areas of the Timeline. You can set your browser to block or alert you about these cookies, but some parts of the Timeline will not then work. These cookies do not store any personally identifiable information. They include cookies that enable you to log into secure areas of our website.
 - **1.3.2.** Analytical or performance cookies. These allow us to recognise and count the number of visitors and traffic sources and to see how visitors move around our website when they are using it. This helps us to measure and improve the way our website works, for example, by ensuring that users are finding what they are looking for easily, and to know which pages are the most and least popular. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our website, and will not be able to monitor its performance.
 - **1.3.3.** Functionality cookies. These are used to recognise you when you return to our website. This enables us to provide enhanced functionality and to personalise our content for you, greet you by name and remember your preferences (for example, your choice of region or cookie settings). If you do not allow these cookies then some or all of these services may not function properly.

- **1.5.** If you do not accept the use of these cookies, please disable them by clicking on the cookie settings links from our cookie banner. You can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. However, if you use your browser settings to block all cookies (including strictly necessary cookies) you may not be able to access all or parts of our website or the Timeline.
- **1.6.** Except for strictly necessary cookies, all cookies will expire after the end of each session.
